Lion Guardians is a non-profit LLC in Kenya working to conserve lions in southern Kenya and northern Tanzania by recruiting young non-literate Maasai warriors to become actively engaged in protecting lions rather than killing them. Lion Guardians monitor lion movement, warn farmers when lions are in the area, recover livestock, reinforce protecting livestock fencing and intervene to stop lion hunting parties.

The Niassa Carnivore Projects work contributes to Wildlife Guardians objective of protecting African lions. The grant was used to promote lion conservation in Mozambique by reducing the number of lions killed in illegal bush-meat snares in the Niassa National Reserve.
