WE HAVE ENTERED INTO A GRANT ARRANGEMENT WITH AN ORGANIZATION IN BOTSWANA TO WHICH WE WILL PROVIDE UNRESTRICTED FUNDING AND CONTRIBUTION OF PERSONNEL TIME. THE ORGANIZATION AIMS TO SCALE EVIDENCE-BASED PROGRAMMING TO YOUTH IN AFRICA VIA A PEER EDUCATION MODEL. IN 2016, THE ORGANIZATION COMPLETED A RANDOMIZED CONTROL TRIAL RESEARCH STUDY OVER ITS FIRST PROGRAM, AN ANTI-INTERGENERATIONAL SEX PROGRAM THAT AIMS TO REDUCE HIV TRANSMISSION THROUGH REDUCING UNPROTECTED SEX WITH OLDER PARTNERS.
