THE ILLINOIS ASSOCIATION OF COMMUNITY ACTION AGENCIES (IACAA) RECEIVES CSBG DISCRETIONARY FUNDING TO PROVIDING TRAINING AND TECHNICAL ASSISTANCE TO THE 37 COMMUNITY ACTION AGENCIES IN ILLINOIS AND TO SUPPORT THE ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY (IDCEO) IN CARRYING OUT THE POLICIES AND STANDARDS RELATED TO CSBG. IACAA PROVIDES TECHNICAL ASSISTANCE TO INDIVIDUAL AGENCIES AND IN LARGER GROUP SETTINGS. IN 2016, IACAA HOSTED AND FUNDED THE RESULTS ORIENTED MANAGEMENT AND ACCOUNTABILITY (ROMA) IMPLEMENTER CERTIFICATION TRAINING WITH 17 CANDIDATES AND THROUGH IACAA'S LEADERSHIP, THERE ARE FIVE NEW CERTIFIED ROMA TRAINERS IN THE ILLINOIS NETWORK. THESE TRAININGS WILL ALLOW AGENCIES TO FULFILL THE FEDERAL ORGANIZATIONAL STANDARDS AND HELP THEM FULLY IMPLEMENT THE PERFORMANCE MANAGEMENT SYSTEM OF ROMA. IACAA OFFERED TWO OF ITS SIGNATURE TRAINING, FAMILY AND COMMUNITY DEVELOPMENT AND THE LEADERSHIP TRAINING WITH NEARLY 100 PARTICIPANTS. OTHER TRAININGS INCLUDE INDIRECT COST RATE TRAINING, BOARD TRAINING, SOCIAL MEDIA MARKETING, POVERTY SIMULATIONS, ORGANIZATIONAL STANDARDS AND STRATEGIC PLANNING. IACAA'S ANNUAL CONFERENCE PROVIDED MORE TRAINING AND NETWORKING OPPORTUNITIES FOR THE COMMUNITY ACTION NETWORK. OVER 1,273 PARTICIPATED IN THESE TRAINING SESSIONS. IACAA PREPARED A CSBG STATEWIDE REPORT USING FY 15 DATA TO SHARE WITH THE PUBLIC, POLICYMAKERS AND THE COMMUNITY ACTION NETWORK ON THE IMPACT OF COMMUNITY ACTION IN ILLINOIS. IACAA FACILITATED A STATEWIDE WORKING GROUP ON BEHALF OF THE ILLINOIS DEPARTMENT OF COMMERCE AND ECONOMIC OPPORTUNITY TO DEVELOP ILLINOIS' VERSION OF A SELF-ASSESSMENT TOOL TO HELP AGENCIES MEET THE 52 FEDERAL ORGANIZATIONAL STANDARDS.
