Under the ABIP Program, stations are inspected by qualified, nongovernmental inspectors to determine compliance with certain FCC regulations and IBA issues certificates of compliance to participating stations which have passed the inspection. The ABIP Program, as a public/private partnership with the FCC, has the effect of raising the level of compliance overall as well as allowing the FCC to more efficiently allocate its limited resources.
