The employees are encouraged to be involved in volunteerism within the communities and most non profit agencies have a BLH representative working with them in some capacity. Bronson has a volunteer time off program where each employee can get up to four hours of paid volunteer time to support community nonprofits. Located on Maple Lake, the Organization makes all decisions with the environment in mind and utilizes green technology whenever possible. This can be found in the attached Audited Financial statements on page 9-10 under Note 2 Significant Accounting policies for Accounts receivable Part III, Line 2. Uncollectible amounts are written off against the allowance for doubtful accounts in the period they are determined to be uncollectible. Bad debt expense is disclosed based on gross charges. For Line 3 bad debt writeoffs support the community by providing a portion of services without payment. The amount of bad debt expense attributable to patients eligible under the financial assistance policy was estimated by reviewing the bad debt detail for a specific write-off code.</p>
