WHETHER IT IS A CHECKING OR SAVINGS ACCOUNT, LOAN, IRA, CERTIFICATE OF DEPOSIT, MORTGAGE OR CREDIT CARD, MSGCU WANTS TO HELP ITS 109,000 MEMBERS ACHIEVE THEIR FINANCIAL SUCCESS. FROM THE START, MSGCU HAS BEEN DEDICATED TO A SIMPLE PURPOSE: SERVING THE FINANCIAL NEEDS OF ITS MEMBERS. WE DO THIS BY PASSING SAVINGS AND ATTRACTIVE RATES TO OUR MEMBERS, OFFERING SENSIBLE SOLUTIONS AND CONSISTENTLY GOING ABOVE AND BEYOND. WE OFFERED OVER 240 FINANCIAL EDUCATION WORKSHOPS IN OUR BRANCHES, LOCAL HIGH SCHOOLS, LIBRARIES AND OTHER LOCATIONS CONVENIENT TO THE PUBLIC AND OUR MEMBERS.

THE CREDIT UNION CONTINUED ITS SCHOLARSHIP PROGRAMS BY PROVIDING \$77,500 TO HIGH SCHOOL SENIORS WHO WILL ATTEND COLLEGE AS WELL TO FIRST RESPONDERS WHO WILL GRADUATE FROM THE FIRE AND POLICE ACADEMIES AT MACOMB COMMUNITY COLLEGE, OAKLAND COMMUNITY COLLEGE AND SCHOOLCRAFT COLLEGE. OVER THE YEARS WE HAVE BEEN RECOGNIZED FOR THE WORK WE DO FOR OUR MEMBERS, EMPLOYEES, AND THE COMMUNITY. MSGCU WAS NAMED MICHIGAN CREDIT UNION OF THE YEAR - 2015 BY THE MICHIGAN CREDIT UNION LEAGUE. THE DETROIT FREE PRESS ALSO SELECTED MSGCU AS A TOP WORKPLACE IN MICHIGAN FOR THE PAST FOUR YEARS. WE ARE PROUD OF A 97% OR HIGHER MEMBER SATISFACTION RATING FOR MORE THAN TEN YEARS AND ACHIEVING THE BAUER FINANCIAL HIGHEST POSSIBLE RATING OF FIVE STARS FOR THE PAST TWENTY YEARS. THESE ACCOMPLISHMENTS CONFIRM THAT WE ARE MAKING A DIFFERENCE IN THE COMMUNITIES WE SERVE IN SOUTHEAST MICHIGAN.


