Delta Dental Fund's purpose is promoting dental education and research, advancing dental science, and promoting oral health of the public by providing funds for charitable projects. Delta Dental Fund has been committed to this purpose for over three decades. Over that time, thousands have benefited from grants and scholarships the Fund has provided. Since the Foundation was established in 1980, we have continually increased our efforts to achieve these goals in Michigan, Ohio, Indiana, and North Carolina. SEE SCHEDULE O FOR CONTINUATIONS. Since 1980, the inaugural year for the Fund, nearly 1000 dental students have been supported through the scholarship program and student leadership awards. In 2016, 53 dental students and dental hygiene students from dental schools in Michigan, Ohio, and Indiana, received financial grants through the Fund to apply toward the cost of education. Delta Dental Fund has provided nearly \$1.4 million in scholarships over the past 36 years. In addition to providing these scholarships, the Delta Dental Fund also continues to recognize fourth year dental students from each dental school with the prestigious Student Leadership Award for their outstanding commitment to dentistry and to their communities. Education does not stop with graduation. Continuing education is necessary to stay current with advancements in treatment and policies and is mandatory to maintaining a license in some states. Delta Dental Fund assists practicing dentists by sponsoring and co-sponsoring seminars in dental science and related topics. In 2016, the Fund in addition to regional seminars, partnered with the University of Michigan, School of Dentistry seminars, that were attended by more than 1,300 dental professionals. On the research front, 2016 marks the ninth year we've awarded nearly \$100,000 in research grants for Master's thesis awards and faculty research. As always, this year's grants are supporting a wide variety of research topics. We continued our Brighter Futures Community Grants program this year in MI, OH and IN and will award \$150,000 in small grants of \$5,000 or less to organizations focused on improving oral health in the markets we serve. This year also marks the sixth year of our Smiles for Kids grant program in North Carolina which focuses exclusively on children's oral health. In Ohio, the Foundation committed \$200,000 to fund a dental clinic at the Academy of World Languages Wellness Center which is a magnet school in the Cincinnati Public School district. This is our second school-based clinic in this area. The first, at Oyler School, has gone on to become a national model for school based health care programs. In Michigan, we awarded \$225,000 to the Michigan Department of Community Health to support the SEAL Michigan and community water fluoridation programs. In addition, we provided the department with funding to implement two fluoride programs for up to 8,000 Flint area children affected by the water crisis. The first program is a school-based fluoride rinse program for students in the elementary grades and the second is a fluoride varnish program for Head Start children. The Foundation's total grants have now exceeded nearly \$25 million since its formation. This funding has improved oral and overall health, added to what we know about dental science, helped students achieve their goals and improved the well-being of thousands of children and adults in the Tristates and North Carolina. Delta Dental Foundation has been active on a variety of fronts this year. It has focused on oral health education, advancing dental science through research, supporting the dental profession and providing care for the underserved.
