EDUCATION PROGRAMS PROVIDED BY THE BRAIN INJURY ASSOCIATION OF MICHIGAN INCLUDED AN ANNUAL TWO-DAY CONFERENCE WITH AN UNDUPLICATED COUNT OF 1,479 WITH BRAIN INJURIES, THEIR FAMILY MEMBERS, PROFESSIONALS IN THE FIELD OF BRAIN INJURY, INSURANCE AND MEDICAL PROFESSIONALS OVER \$4,061 IN REDUCED REGISTRATION FEES WERE PROVIDED TO 53 PERSONS WITH BRAIN INJURIES AND/OR THEIR FAMILY MEMBERS ATTENDING THE CONFERENCE. THE EIGHTH ANNUAL SPECIALTY CONFERENCE "QUALITY OF LIFE" FOCUSED ON STRATEGIES FOR IMPROVING ONES' LIFESTYLE AND METHODS TO DEAL WITH ISSUES FACED BY PERSONS WITH A BRAIN INJURY. 96 ATTENDEES WERE REGISTERED AND 11 SPONSORS AND EXHIBITORS PARTICIPATED. THE FOURTH ANNUAL LEGAL CONFERENCE WAS HELD TO FOCUS ON THE COMPLEX LEGAL ISSUES FACING A BRAIN INJURED CLIENT. LEARN ABOUT THE LEGAL SYSTEM AND THE PROTECTION AND RESOURCES IT OFFERS. 186 ATTENDEES WERE REGISTERED AND 28 SPONSORS AND EXHIBITORS PARTICIPATED. MEMBERS AND THE GENERAL PUBLIC WERE ABLE TO UTILIZE THE ASSOCIATION'S LIBRARY AND RESOURCE ROOM, WHICH CONTAINS THOUSANDS OF ARTICLES, BOOKS AND VIDEOS. THE BRAIN INJURY ASSOCIATION OF MICHIGAN'S EXHIBITED AND DISTRIBUTED INFORMATION AT 21 COMMUNITY EVENTS REACHING 5,000 INDIVIDUALS, IN ADDITION TO THE SEVERAL THOUSAND AT THE ANN ARBOR ART FAIR WEBINARS. DUE TO AN EVER-INCREASING NUMBER OF FREE WEBINARS OFFERED BY OTHER PROVIDERS, THE BRAIN INJURY ASSOCIATION OF MICHIGAN ONLY CONDUCTED ONE WEBINAR IN 2016 ATTRACTING A TOTAL OF 11 PARTICIPANTS. ACBIS WHILE THE CONTINUING RECONSTRUCTION OF THE PROGRAM BY BIAA IMPACTED THE NUMBER OF TRAININGS PROVIDED, THE BRAIN INJURY ASSOCIATION OF MICHIGAN NONETHELESS INCREASED ITS YEAR-OVER-YEAR TRAINING BY 93% FROM 54 IN 2015 TO 96 IN 2016. GRANTS TWELVE EDUCATIONAL SCHOLARSHIP GRANTS OF \$1,000 EACH WERE AWARDED TO GRADUATING HIGH SCHOOL SENIORS PURSUING A CAREER IN EITHER HEALTH CARE OR REHABILITATION FIELDS. THIS PROGRAM IS THE RESULT OF THE SUPPORT OF SPECIAL TREE REHABILITATION SYSTEMS.

IN ADDITION, OUR ENHANCED WEBSITE WITH 177,455 VISITS AND IN EXCESS OF 244,159 PAGES VIEWED OF WHICH, 170,635 WERE UNIQUE VISITS. 3) THE SURVIVORS' COMMITTEE MET PERIODICALLY AND ORGANIZED RECREATIONAL ACTIVITIES. IN THE SPRING, A SHOPPING "SPRING FLING" WEEKEND WAS HELD FOR 53 PERSONS WITH BRAIN INJURIES AND THEIR FAMILY MEMBERS.
