MSA operates its funding to student organizations through a reimbursement process. Registered UM student organizations must apply to MSA for funding events that directly affect the greater UM student/non-student community. Programs that include educational components and themes are encouraged. All funding is awarded through a reimbursement process where UM student organizations are required to submit authentic proof of applied for and awarded expenses, and MSA verifies such expenses and reimburses the student organizations with a grant for approved expenses. MSA retains all student organization funding applications and proof of expenses up to 5 to 7 years.

All awarded funding is decided by a student funding body comprised of at least 10 to 30 students, including MSA elected representatives and UM students-at-large. All MSA awarded funding is reimbursed during the appropriate UM academic semester as the funding was applied for and within the same academic year.

MSA does not fund any lobbying activities or political activities of registered/recognized student organizations at the University of Michigan.
