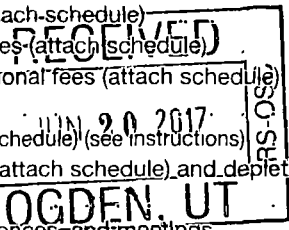

7. The student must show promise and leadership qualities and be involved in campus activities.
8. Applications must be received by July 15 of the academic year for which aid is sought.
9. If you have received a George Harding Scholarship in the past, you are not eligible for another one.
