The Western Marquette County Health Foundation will provide funding in the form of grants to non-profit agencies. Grant applications will be reviewed bi-annually on a competitive basis, with funding provided to those applications that seek to enhance health and wellness in the region. Success will be determined based on individual proposals, impact on the community, and sustainability. Grants for operational costs will receive low priority. Grant size varies based on request, however the average size is expected to range from \$1,000-\$10,000. Multi-year grants will be accepted, based on board approval of progress reports.
