Central MN Re-Entry Project (CMNRP) received 112 reentry applications from 7 MN state prisons, tri-county jails and halfway houses. 10% were women and 10% were veterans.

Assistance with housing, employment, medical insurance, food, furniture and other mainstream resources is offered.

Direct/financial assistance is offered when available.

32 ex-offenders were housed in CMNRP transitional housing units. 29 of the 32 have secured employment.

22 transitioned to permanent housing; 12 were referred to local landlords; 10 secured housing on their own with a CMNRP reference.

Mentoring is available to transitional housing residents.

Since 2011, there has been a 31% recidivism rate for applicants who enroll in the CMNRP housing program. This is compared to a 66% national recidivism rate within three years of release from incarceration.

CMNRP also offered a weekly on-site support group during 2016

The Community Furniture Program (CFP) provides gently used, donated furniture for households transitioning out of homelessness and poverty. 411 households, consisting of 1379 individuals, were served by CFP; 50% were children and 60% were refugees.

CFP utilized 20 volunteers and employed 2 ex-offenders during 2016
