ENVIRONMENTAL HEALTH PROGRAM IN 2016, WE WORKED LOCALLY TO SPREAD AWARENESS OF ARSENIC IN MAINE'S WELL WATER, TO PUBLICIZE THE PRESENCE OF TOXIC PHTHALATES IN VARIOUS CONSUMER PRODUCTS, AND TO PROTECT FIREFIGHTERS AND FAMILIES FROM UNNECESSARY AND CARCINOGENIC FLAME RETARDANT CHEMICALS WE ALSO WORKED NATIONALLY, PROVIDING CRITICAL LEADERSHIP TO A NATIONAL COALITION THAT PLAYED A KEY ROLE IN FORMULATING HARD-WON CHEMICAL POLICY REFORM AND IS NOW MONITORING THE POLICY'S IMPLEMENTATION WHILE ARSENIC IS A WELL-KNOWN TOXIC, MOST MAINERS ARE UNAWARE THAT 1 IN 8 PRIVATE DRINKING WATER WELLS IN THE STATE ARE FOUND TO HAVE UNSAFE LEVELS OF THE POISON DESPITE THIS HIGH RISK, FEWER THAN HALF OF THESE WELLS HAVE ACTUALLY BEEN TESTED WE LOGGED NEARLY 5,000 MILES CRISSCROSSING THE STATE TO SPREAD AWARENESS OF THE PROBLEM, HELP FAMILIES GET ACCESS TO WATER TESTS, AND PROMOTE THE NEED FOR PROTECTIVE STATE POLICIES AND INCREASED RESOURCES TO HELP WORKING FAMILIES AFFORD COSTLY TREATMENT SYSTEMS BASED ON OUR REGULATORY ADVOCACY, MAINE BECAME A NATIONAL LEADER IN COLLECTING DATA FROM INDUSTRY ON THE USE OF CERTAIN TOXIC PHTHALATES IN A VARIETY OF CONSUMER GOODS THIS UNIQUE DATA SHOWED THE USE OF THESE CHEMICALS IN PAINTS AND OTHER BUILDING SUPPLIES OUR REPORT, "WHAT STINKS?
