We work with about 90 different agencies that serve Veterans and Active Duty Reservists. We provide practical home furnishing through the donations from the community is our main focus. Through other agencies we connect rescued companionship animals with our Veterans and we also connect them to get training for these animals to become certified service animals. Everything we do for our Veterans is a no cost to them. We serve all Ranks, Branches, Discharge status, injured or not. They provide proof they have served and we help them, no RED tape is involved in getting them the home furnishing items, food donations, animals or information on other resources.
