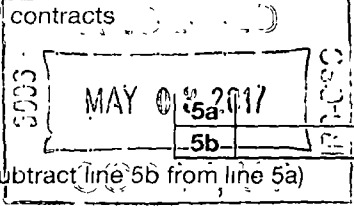

The purpose of "i43, inc " is to encourage, equip and empower the Christians and the local churches to fulfill the Great Commission (from
Matthew 28 18-20) of Jesus Christ to the ends of the earth. The name of the organization comes from Isaiah 43 6-7,21. This ministry was birthed out
of prayer in the spring of 2011. God is bringing people of all nations to this country, many are coming for a better life. The churches have the privilege
of sharing the truth and love of Jesus Christ to each and every one of the immigrants, refugees, and international students. To that end i43 promotes
prayer meetings, evangelism seminars, missionary training workshops, short term missions and outreach events. i43 also established ESL center in
Leesburg in the fall of 2013 to help the local churches engage with the immigrant community and provide practical help regardless of their
ethnic or religious background. During the past 2-3 years we have also helped 4 local churches to launch their own ESL ministry.

Barnabas - meals, donations to ministries of missionaries abroad.

Travel - airfare, car rentals, lodging and meals while on travel for ministry purposes (speaking at churches).

Conferences - conference fees and travel & lodging associated with particular conference.
