All residents must be currently on probation or parole or Federal Pre-Release status. The program provides a structured environment, where residents can develop the necessary skills to live in an independent crime and drug free lifestyle. Specifically, the program provides room & board, individual and group counseling, transportation and employment assistance, and twenty-four (24) hours supervision, and referrals to other agencies for services not directly provided at Parsons House. The program has capacity for 40 residents. In 2016 approximately 113 offenders were served, 94% successfully completed the program and 96% were employed at discharge.
