THE WISCONSIN DEPARTMENT OF TRANSPORTATION IS THE ASSOCIATION'S MAIN FOCUS AS IT IS RESPONSIBLE FOR ALL INTERSTATE AND STATE HIGHWAYS AS WELL AS ALL AIRPORT FACILITIES IN WISCONSIN.
