CALLERS ARE REFERRED TO PROGRAMS WHICH CAN HELP THEM IN THEIR RESPECTIVE COMMUNITIES. IN 2016 3866 CALLS WERE HANDLED, AN INCREASE OF 222 OVER 2015. THE TOP NEEDS WERE FOR RENTAL ASSISTANCE, FOOD AND ELECTRIC PAYMENT ASSISTANCE.
