Our mission at Marinette County Elderly Services is to assist older persons in maintaining a longer, healthier, and more fulfilled life.

NUTRITION PROGRAM: Provides hot, nutritious meals (Congregate and Home Delivered) for persons age 60 and over. Promotes physical health, nutrition counseling and education. Provides information regarding additional concerns of aging. In 2016, 51686 meals were served to 557 individual clients, and transportation (517) rides to meal sites were provided for those lacking other means of transportation. Of meals served, (33031, or 63%) were provided to homebound, often frail elderly unable to cook or provide their own meals.

4b (Code:) (Expenses \$ 129731 including grants of \$) (Revenue \$ 132454)
TRANSPORTATION PROGRAM: Provides transportation via bus, van, and private auto for medical, social, nutrition, employment, personal business. Many elderly clients are frail and require private auto escort and/or wheelchair-lift assistance in accessing Agency vans and buses. In 2016 the Agency provided 5393 one-way passenger trips of which 1053 were for medical appointments (489 for frail elderly) and 537 trips for disabled riders. Remaining rides were for nutrition, employment, education, and social and recreation.

LEGAL AND BENEFIT COUNSELING: Provides support to individuals and families Alzheimer's Disease and related dementias including support groups and grants to affected individuals. Programs include Alzheimer's Family Caregiver Support, Family Caregiver Support (for related dementias and health issues), Medical and Prescription Drug Assistance, Community Outreach, Information and Assistance, Respite Care and related supplies assistance. 12 Clients received full or partial grants via Alzheimer's and/or Family Caregiver Support Programs. About 613 individuals were assisted with Homestead Tax, Medicare, Medicaid, SSI, Senior Care, Prescription Medication and consumer issues. About 8644 contacts were processed via Information and Assistance Staff.

(5) The remaining \$3651 in expenses and \$4779 in revenue were allocated in support of misc. program costs and were allocated to misc. revenues. Unspent funds of \$1878 (Building Acquisition, Misc. above) were carried over into our 2017 Fund Balance.
