On September 27, 2015, prior to the dissolution of Epiphany Lutheran Church, the Organization's members voted to substitute Our Redeemer Lutheran Church as the supported organization. This substitution was authorized under Article 3 of the Organization's Articles of Incorporation. The substitution was accomplished by filing Articles of Amendment with the Wisconsin Department of Financial Institutions and amending the Organization's bylaws. The Articles of Amendment were effective October 2, 2015, and filed with the Wisconsin Department of Financial Institutions on October 5, 2015. Under the amended bylaws, the Organization's voting members are now members of Our Redeemer Lutheran Church, ages 18 and older."
