EARLY INTERVENTION AND TREATMENT SERVICES IS A UNIQUE PROGRAM THAT INCLUDES A COMPREHENSIVE, INDIVIDUALIZED SERVICE MODEL PROVIDING ASSESSMENT, REFERRAL, ADVOCACY, PLAY THERAPY, PARENT EDUCATION, INDIVIDUAL AND FAMILY THERAPY, IN-HOME SERVICES, AND CONSULTATION. IN 2016, MORE THAN 4,800 DIRECT HOURS OF SERVICE WERE PROVIDED AND OVER 400 NEW REFERRALS WERE RECEIVED. THE POPULATIONS SERVED ARE YOUNG CHILDREN (PRIMARILY INFANTS THROUGH 10 YEARS OF AGE) AND THEIR FAMILIES WHO HAVE EXPERIENCED TRAUMA INCLUDING CHILD ABUSE (PHYSICAL, SEXUAL, AND PSYCHOLOGICAL), NEGLECT, DOMESTIC VIOLENCE, GRIEF/LOSS, SERIOUS ACCIDENTS, BEHAVIORAL HEALTH CHALLENGES, AND OTHER STRESSORS.
