THE GRANT ENABLED WAPC TO TAKE THE LEAD IN THE FORMATION OF THE WISCONSIN PERINATAL QUALITY COLLABORATIVE AND TO CONTINUE UPGRADES AND ENHANCEMENTS TO PERIDATA.NET. IN ADDITION, FUNDING OF \$55,840 WAS PROVIDED FOR STAFFING COSTS WHICH SUPPORT PERINATAL PROGRAMS. OF THIS AMOUNT, \$27,714 WAS ALLOCATED TO PROGRAM SERVICE EXPENSE.
