Finalists are re-reviewed, references checked, the top three candidates are presented to the full Board with recommendations from the selection committee and the Executive committee. The Board makes the final decision on offers, salary, benefits, and any extra considerations.

PART X, Balance Sheet - During 2016, the books of Wild Ones were totally overhauled. The organization went from Accrual to Cash Basis, strict fund accounting was implemented, 2015 end-of-year entries were evaluated for errors and misstatements and corrections were made, accounts were re-cast from a traditional accounting line up to a functional layout, thus allowing for analysis by function, i.e., donations, membership, PSR, G&A, and Chapter activities, and, every account was tied to a specific 990 line item, thus allowing for consistent year-to-year reporting as well as more accurate and dependable transfers of financial statement data. All beginning balances were re-stated.

PART XI, Reconciliation - The above changes resulted in \$19,709.20 in prior period adjustments. But now we are assured that all fund balances match perfectly to equity. In addition, for the first time we have the ability to generate detailed financial statements for each of the 50+ chapters.

PART XII, FS Reporting - as stated above, the organization went from accrual accounting to cash basis.
