The Sheboygan County Food Bank worked throughout the calendar year to raise funds to purchase food for needy individuals and families in the greater Sheboygan County, Wisconsin area. It also worked to secure significant donations of food for distribution to needy individuals and families in its service area. In addition, it generated volunteer support from over 200 volunteers, who donated over 2,000 hours of their time to assist with food collection and distribution. Further, it also prioritized raising public and corporate awareness of the significant hunger and malnourishment needs in the community. The food bank worked primarily with ten church and NFPO run local food banks in the county to identify and prequalify needy recipients and to distribute food to those needy individuals. Because of its efforts, over 300,000 pounds of food was distributed to over 1,000 needy individuals in 2016.
