WISDOM's "ROC Wisconsin: Restoring Our Communities" Campaign continues with four major workgroups, established state-wide to educate and mobilize the public around these initiatives: fully achievable plans to keep people from entering prison and help people stay out of prison, and the release of nearly 3,000 people who are eligible for it right now. WISDOM's EXPO, EX-Prisoners Organizing, now has chapters in Kenosha, Racine, Milwaukee, the Fox Valley, Wausau, Eau Claire, and Madison. Composed of EX-Prisoners and their loved ones, EXPO leads most of WISDOM's criminal justice work. WISDOM also organizes around efforts to 1) make our communities safe and welcoming to immigrants, and 2) assure adequate funding for public transit. WISDOM provides leadership training workshops in each of the 10 affiliate organizations, sends more than 40 leaders annually to Gamaliel's week-long National Training Institute, provides four 2-day training workshops for leaders and has training components during the annual Board Retreat and at 3 board meetings. A new initiative frames all of WISDOM's work within racial justice.
