THE FOUNDATION CREATES PERMANENT ENDOWMENT FUNDS AND NON-ENDOWED FUNDS TO SUPPORT EDUCATIONAL OPPORTUNITIES IN MADISON'S PUBLIC SCHOOLS AND PROVIDES SUPPORT TO 50 SCHOOLS TO RAISE FUNDS FOR THEIR ENDOWMENTS AND IN THE ANNUAL GRANT PROCESS. IN 2016, \$90,322 WAS AWARDED THROUGH THE INDIVIDUAL SCHOOL ENDOWMENTS. THE FOUNDATION ALSO PROVIDES SUPPORT IN RAISING AND DISBURSING FUNDS FOR 46 DESIGNATED ENDOWMENT FUNDS. IN 2016, \$51,515 WAS AWARDED. THE FOUNDATION ALSO PROVIDES SUPPORT IN RAISING AND DISBURSING FUNDS FOR 55 NON-ENDOWED FUNDS. IN 2016, \$593,315 SUPPORTED A VARIETY OF SCHOOL PROGRAMS AND PROJECTS. THE FOUNDATION AWARDS GRANTS FOR CREATIVE AND INNOVATIVE PROJECTS IN MADISON'S PUBLIC SCHOOLS THROUGH A COMPETITIVE GRANT PROCESS. IN 2016, FOUR GRANTS TOTALING \$92,000 FUNDED PROJECTS IN FOUR SCHOOLS AND TO FOUR PROGRAMS LED BY THE MADISON METROPOLITAN SCHOOL DISTRICT. THE FOUNDATION MONITORS AND EVALUATES THE PROGRESS OF THESE GRANTS. THE FOUNDATION ALSO DEVELOPS SUPPORTIVE RELATIONSHIPS BETWEEN MADISON'S PUBLIC SCHOOLS AND THE COMMUNITY TO ENRICH THE EDUCATION OF CHILDREN. THE FOUNDATION HOSTS AN ANNUAL PRINCIPAL EXPERIENCE TO GIVE FIRST-HAND EXPERIENCE OF WHAT IS HAPPENING IN THE SCHOOLS. IN 2016, 93 BUSINESS AND COMMUNITY LEADERS PARTICIPATED IN THE 13TH ANNUAL EVENT. THE FOUNDATION ALSO WORKS WITH LOCAL BUSINESSES AND ORGANIZATIONS TO PROVIDE HUMAN, MATERIAL, AND FINANCIAL RESOURCES TO SCHOOLS THROUGH THE ADOPT-A-SCHOOL PROGRAM. IN 2016, THERE WERE A TOTAL OF 62 PARTNERSHIPS THROUGHOUT THE SCHOOL DISTRICT. IN 2016 THE BIENNIAL ADOPT-A-SCHOOL SUMMIT WAS HELD WITH 137 ATTENDEES WITH A FOCUS ON HOW TO DEVELOP AND GROW CURRENT AND POTENTIAL ADOPT-A-SCHOOL PARTNERSHIPS. THE FOUNDATION PROVIDES OPPORTUNITIES FOR THE GENERAL PUBLIC TO CONNECT WITH THE SCHOOLS. THE ANNUAL CIRCLE OF FRIENDS LUNCHEON SHOWCASES SUCCESS IN MADISON'S PUBLIC SCHOOLS AS WELL AS HIGHLIGHTS HOW THE FOUNDATION IS ABLE TO MAKE AN IMPACT THROUGH ITS PROGRAMS AND INITIATIVES. THE 2016 LUNCHEON HAD 613 ATTENDEES AS WELL AS CORPORATE SPONSORSHIP. IN ADDITION, THE FOUNDATION'S REPORT TO THE COMMUNITY IS PASSED OUT AS A LUNCHEON PROGRAM AND GENERAL UPDATE ON THE PAST YEAR'S ACTIVITIES. THE REPORT IS ALSO SHARED WITH PRINCIPAL PARTNERS AND PRINCIPALS. IN ADDITION THE REPORT IS SHARED VIA EMAIL TO STAKEHOLDERS AND IS AVAILABLE ON THE FOUNDATION'S WEBSITE AND UPON REQUEST.
