 The union through employees, members and mediation specialists negotiated approximately 150 contracts covering 13,500 members. The objective of these contract negotiations is to provide members with improved working conditions, job protections, better benefits and higher wages. The union resolved over 300 grievances of which 24 were referred to the Council Arbitration Screening Panel for approval. 16 of the grievances were approved for arbitration. The union also ran 14 separate organizing campaigns. The union also did member training in contract enforcement, organizing and community outreach. Board members, employees, and members also attended conferences and conventions to ensure involvement in governance and setting the union's mission.
