If not used, the carryover losses expire in 2029. Deferred tax assets result from carryover losses. Realization of the deferred tax asset is dependent upon sufficient future unrelated business taxable income during the period that loss carryforwards are expected to be available to reduce unrelated business taxable income. A deferred tax asset of \$7,581 has been recorded net of a \$7,581 valuation allowance. The Association believes that it has appropriate support for any tax positions taken, and accordingly, does not have any uncertain tax positions that are material to the financial statements.
