In 2016 the Community Foundation awarded \$3,382,691 in grants and \$313,120 in scholarships. Total grants awarded (including interfund grants) comprised of 19% unrestricted funds, 6% designated, 49% field of interest, 9% organizational endowments, 8% scholarships and 9% donor advised. The largest program area supported was human services with 59% of grant funds, followed by 11% in education, 4% in arts, 11% in environment, 5% community and economic development, 2% other, and 8% scholarship. In 2016 the Community Foundation awarded \$247,320 scholarships from endowed funds and \$65,800 from 10 temporary scholarship funds that the Foundation provides scholarship services. In addition the Foundation provided administrative services for two affiliated scholarships totaling \$549,800 where all of the funds are held by a local bank, plus \$89,100 of Grants where all funds are held by a city.

Public Education In 2016 DSACF collaborated with multiple communities through out the United States to improve public discourse through Speak Your Peace the Civility Project Initiative. 2016 was the 2nd year for DSACF to participate in a new philanthropic based disaster-preparedness, response and recovery program known as the Preparedness, Resiliency and Emergency Partnership (PPREP). Designed to help community foundations implement a philanthropic response to disasters, both in the immediate aftermath and during long-term community rebuilding and resiliency. In 2016 DSACF received grant funding to create the Opportunity Gap Initiative to address the inequity in opportunity that one culturally, racially and/or financially similar group has in comparison to another. The vision, beginning with an initial group of grantees, is to develop a community that embraces diversity and inclusivity, where all children have abundant opportunities, and feel respected, safe and secure. DSACF is continuing to evaluate the work of grantees' in addressing the Opportunity Gap and raise funds for an Endowed Fund to further this work.
