There were no new loans approved or drawn down in 2016. A total of \$72,428 and \$11,904 in loan principal and interest repayments were collected during the year. We are working with one particular borrower who is experiencing financial distress. The corporation recently modified it's by-laws to allow for certain new loans to contain a portion of forgiveness based on the number of qualifying jobs created.
