Senior Nutrition including Title III-C MAAA funds three (3) nutrition contractors, one of whom has subcontractors, to provide a combination of congregate (dining in a community/senior center, or in housing where the majority of residents are age 60+) and/or home delivered meals. The meals are targeted to low-income, socially isolated individuals, with particular attention to low-income minorities and those with limited English proficiency - all of whom are at high-nutritional risk, and have high levels of food insecurities. In 2016, these programs served 405,990 congregate meals to 5,617 persons, 253,274 home delivered meals to 1,612 persons.

Information and Assistance (Long-term care options consulting, housing with services consultation, prescription drug assistance, return to community and health insurance counseling) In 2016 MAAA assisted 88,426 older adults, family caregivers and service professionals through our Senior Linkage Line(R) to evaluate needs, connect to services, learn about housing options and get answers to medicare, insurance and prescription drug payment questions. The agency's community living specialists met with 1,850 private-pay nursing home residents and provided 439 of those individuals with in-depth assessment and care coordination. MAAA staff processed approximately 35,199 screenings through Pre-Admissions Screening. The screenings are intended to identify individuals whose needs might be better met in the community and connecting them to home and community-based services. In 2016, 105 volunteers contributed 7,472 hours to program activities assisting in many service areas, including the Medicare Phone Bank, face-to-face health insurance counseling, education and outreach.

Program Development and Coordination As a partner to 33 Local Service Providers, MAAA provided leadership training, consultation on program start-up and marketing for five evidence-based health promotion programs: Matter of Balance, LivingWell with Chronic Condition, Living Well with Diabetes, Tomando Control de su Salud, and Tai Ji Quan: Moving for Better Balance. Over 1,500 older adults participated in the programs at 72 different community sites. With funding from the Greater Twin Cities United Way, MAAA provided technical assistance, best practice information, through a Livable Communities Forum, and learning collaborative to 28 metro area communities as they prepare their communities to support an aging population. In addition, MAAA conducted an evaluation of Metro Livable Community efforts and published the findings in a report available on metroaging.org. MAAA participated in the Act on Alzheimer's Collaborative Project to improve detection, treatment and community support to people with Alzheimer's Disease and their care partners by providing technical assistance to 17 local communities working to become dementia friendly. In support of persons with dementia and their families As a partner in the ElderCare Development Partnership, with funding from the Minnesota Department of Human Services, MAAA conducted the following activities: provided educational sessions to targeted health care and HCBS systems, care coordinators and providers to improve effective connections to community supports, provided technical assistance and sustainability consultation to Live Well at Home applicants and grantees including in-depth service design for organizations, provided 2 training workshops on Live Well at Home to providers and Live Well at Home grantees and advanced practice consultation to interested providers, provided 2 workshops to increase knowledge of program and service evaluation, sustainability and use of technology supports, and recruited new partners who will deliver more evidence-based health promotion programs, continue pilot projects with health care providers with plans to deliver one or more services to a defined population, as well as test new reimbursement/funding models for program expansion. MAAA also facilitated the Twin Cities Aging Network, a business-acumen learning collaborative aimed at building partnerships with health care organizations. The network began development of a pilot project with a local health care provider organization to test the impact of community-based service utilization on health care outcomes. As a co-convenor and facilitator of the Metro Caregiver Service Collaborative, MAAA fosters education for providers, outreach to caregivers and referral partners, and supports advocacy initiatives for caregiver needs. MAAA also publishes the working caregiver to link 173 employers, and others interested in supporting working caregivers, with business policy options and practical resources to support caregiver employees. Data Management Program Under contract with the Minnesota Department of Human Services, the organization provided ongoing management of the State's Long Term Care database to maintain accuracy and currency and to conduct a continuous quality improvement process. The Data Management Program (DMP) maintains the currency of existing resource data and adds new resources based on data submitted by providers and users, data gleaned from provider websites, and lists of data obtained from regulatory and other external agencies. During 2016, the DMP completed a total of 12,224 full agency reviews. In 2016, the DMP worked closely with the Minnesota Board on Aging to support new search functions on the Minnesota Help website, provided outreach to agencies in support of the Home and Community Based Services Finder, supported the Consumer Review pilot project, assisted with the Children and Youth with Special Health Needs Navigator (CYSHN), and began work on redevelopment of the Data Manager tool. The DMP provided data analysis, tool design recommendations, and business process modeling recommendations. Upper Midwest Pension Rights Project The organization's staff attorneys and law student interns provided comprehensive pension counseling, information and referral services in a five (5) state area with local partners in Minnesota, Wisconsin, Iowa, North and South Dakota.
