In 2016 Winona Area Ambulance Service had 42 standbys and donated 10 hours of standby time to the community. Winona Area Ambulance Service, Inc. is an advanced life support service that provides coverage for approximately 100 square miles, including the cities of Winona, Goodview, and other surrounding communities in Minnesota and Wisconsin. We provide 911 coverage, non-emergency calls, transfers, standbys, and intercepts for surrounding basic life support services. We also provide training and continuing education for area emergency responders and healthcare providers.
