The AmeriCorps field program engages young adults, ages 18 to 25, in natural resource conservation and emergency response throughout the upper Midwest. In 2016, 191 participants served 8-11 month terms and 16 participants served 3 month summer terms restoring habitat throughout the Midwest. Field members contributed 310,822 hours of AmeriCorps service this year, removing invasive species and hazard trees from 11,910 acres, planting 164,655 native trees and shrubs, conducting prescribed burns on 23,305 acres of prairie, improving 1,380 miles of trail or waterways, installing or maintaining 570,655 square feet of rain gardens, controlling erosion on 184,135 square feet of shoreline, suppressing 2,882 acres of wildfire, dedicating 10,682 hours to helping communities recover from natural disasters, and more. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses. Beside career and work-skills training, members receive certifications in wildfire suppression, defensive driving, chain-saw safety and first aid.

4b (Code) (Expenses \$ 541,860 including grants of \$) (Revenue \$ 159,950)

The residential Summer Youth Corps engages diverse youth, ages 15-18, in environmental-restoration projects during two summer sessions, each four weeks long. In 2016, 148 youth participants, 23 AmeriCorps members, and 4 part-time staff completed 33,165 hours of environmental service-learning projects. Three-quarters of the 148 youth were from populations underrepresented in natural resources careers. In addition to natural-resource work experience, they learn skills such as civic leadership and resume writing. This past year, youth crews built and maintained 226 miles of trail, managed exotic plant species on 1,171 acres, rehabbed 136 campsites, and engaged in 4,045 hours of training and environmental education. Participants receive a living stipend as well as room and board. Youth begin at a base camp, then "spike camp" throughout the region as they work. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses.

4c (Code) (Expenses \$ 1,091,004 including grants of \$) (Revenue \$ 622,235)

Youth Outdoors is an afterschool service-learning program for Twin Cities youth, ages 15-18 from low-income households. Youth participate for one academic semester at a time, meeting two days a week after school and on Saturdays to explore science and the environment and complete projects to improve parks and restore resources. Summer opportunities are also available. In 2016, 117 youth participants and 34 AmeriCorps members completed 45,218 hours of environmental service-learning projects. This past year, Youth Outdoors participants managed exotic plant species on 647 acres of land, planted 5,203 trees and shrubs, removed 3,268 pounds of debris, and engaged in 8,312 hours of training. Youth participants earn an hourly wage. AmeriCorps members receive a monthly stipend, health insurance and an education award for college expenses. Beside career and work-skills training, members receive certifications in wildfire suppression, defensive driving, chain-saw safety and first aid.

(Code) (Expenses \$ 712,836 including grants of \$) (Revenue \$ 310,307)

Single placement opportunities for AmeriCorps members engage young adults, ages 18 to 25, in natural resource, energy conservation, community outreach and emergency response work. In 2016, 9 participants served terms on special projects with the Minnesota and Iowa DNR, 5 served terms improving energy efficiency in houses and conducting outreach, 7 served terms conducting environmental education, and 31 served summer terms completing natural resource projects. AmeriCorps members dedicated a total 49,510 hours of service. Corps members planted 41,029 native trees and shrubs, seeded 135 acres, completed 3,764 hours of GIS data collection and mapping, collected 1,845 water quality samples, implemented energy-saving measures in 2,489 homes, and provided education to 5,073 people. AmeriCorps members receive a monthly stipend, health insurance, and an education award for college expenses.
