

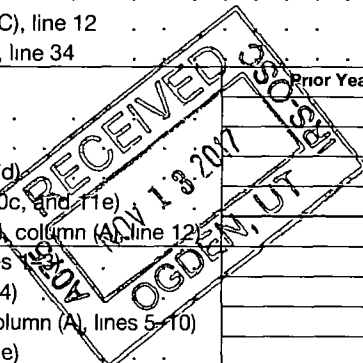

Our participants are children and adults ages 4-85 who are challenged by a wide range of disabilities including autism spectrum disorder, cerebral palsy, Down syndrome, and developmental delay. They receive physical, cognitive and emotional benefits. They gain self-confidence and self-esteem, build strength, improve balance and hand-eye coordination, while forming meaningful relationships.
