Metropolitan and Transportation Equity - ISIAIH worked to build a broad-based coalition and to organize people of faith across the Metropolitan region to advance a vision for transportation choices for all people in Minnesota. ISIAIH, in particular, focused on increased bus service, equitable distribution of transit investments such as heated bus shelters and worked to educate state, regional and local decision-makers about the transit needs in low-income communities across the Metro region and across Minnesota. ISIAIH launched the #HowWeRollMN Campaign that put the voices of transit riders at the center of the public debate about transportation investments in Minnesota. ISIAIH also worked to advance fair housing in the region by working with housing advocates and the Metropolitan Council on the 2020 plan. ISIAIH worked to ensure that affordable housing would be a goal for second and third ring suburbs of the Metro area. Education and Ending the School To Prison Pipeline - ISIAIH worked with parents, grassroots leaders, faith leaders and advocates to raise awareness about the disproportionate impact school discipline policies have on black and brown children. ISIAIH worked to negotiate moratoriums on suspensions for K-5th grade students with the Osseo, Robbinsdale and Minneapolis school districts. ISIAIH also educated and worked with state decision-makers on the growing need for more school counselors for public schools. Criminal Justice Reform - ISIAIH launched a campaign to end Mass Incarceration, focusing on the entry points for young people of color into the criminal justice system. Connected to the ongoing campaign to reform school discipline policies, ISIAIH worked with grassroots faith leaders, parents and advocates to advance a conversation about reforming the juvenile justice system through effective programs such as JDAI. ISIAIH worked to renew critical funding for JDAI programs and worked to expand the JDAI program to more counties across Minnesota. This campaign also focused on questioning harsh sentencing for young people such as mandatory minimums, shackling in court and life without parole. Immigrant Organizing and Inclusion of Immigrants in Minnesota - ISIAIH launched a partnership with ten predominantly Latino faith communities across Minnesota. Through a process of training, leadership development, ISIAIH formed a steering committee of Latino faith leaders to launch a campaign to restore access to drivers licenses for undocumented immigrants in Minnesota. The ISIAIH Latino organizing committee held public gatherings with officials from the Governor, the Speaker of the House, local legislators across 14 districts in Minnesota. In partnership with a wider coalition, ISIAIH leaders built partnership with law enforcement, religious denominations and small businesses and garnered bi-partisan support for the inclusion of immigrants, starting with access to Drivers Licenses. ISIAIH also worked to build relationships with federal officials to advance comprehensive immigration reform at the national level. Health Equity and Working Families - ISIAIH has a long term program to connect all the issues across the organization to an analysis around health. Health equity is the work of ensuring the conditions that people and communities need to be healthy. If people do not have access to safe neighborhoods, healthy food, accessible transit, economic opportunity, strong schools and clean, safe housing, then it is very difficult for them to be healthy. Beyond the work toward building healthy communities broadly, ISIAIH also directly worked to connect health equity to campaigns for raising the Minimum Wage, Paid Sick Days and Paid Family and Medical Leave. ISIAIH partnered with state and local public health officials to begin to connect the extensive data that correlates health and income and maternal health and paid leave, to a state-wide conversation about raising standards for working people.
