Exhibition Program Each year, Midway originates and produces four-five exhibitions. These new projects by artists from Minnesota and around the world connect our local audience to artists working globally. Our exhibitions typically involve the creation of new, project-based work. We cover all fabrication, framing, shipping, travel, and related expenses, we also provide extensive technical support, often helping the artist to engineer and create the project on-site. We also offer exhibiting artists and guest curators a \$5,000 stipend. We produce catalogs alongside selected exhibitions. Library Since opening in 2007, our library has held one of the most current collections on contemporary art in the region. This non-circulating, 7,000-volume resource is easily accessible, adjacent to our gallery and has regular hours. Visitors do not need an appointment and can browse at their leisure, making it useful as an introduction to the field as well as for in-depth research. The library database has a prominent location on our website, where students, artists and researchers can search remotely. Visual Arts Fund The Visual Arts Fund is a new grant program established by Midway Contemporary Art with generous support from The Andy Warhol Foundation for the Visual Arts. Minneapolis-St Paul will be the eleventh metro area included in Warhol's Regional Regranting program, which is aimed at promoting vibrant artistic activity in cities across the United States. The Visual Arts Fund will award five \$5,000 and three \$10,000 grants to artists in the Twin Cities metro area, beginning in 2016. The VAF supports the development of new, experimental projects and initiatives happening outside of established venues that engage the public with visual art in a new way. Projects might include exhibitions or installations held in temporary spaces, new publications, series of events or performances, digital initiatives, and other activities occurring not occur
