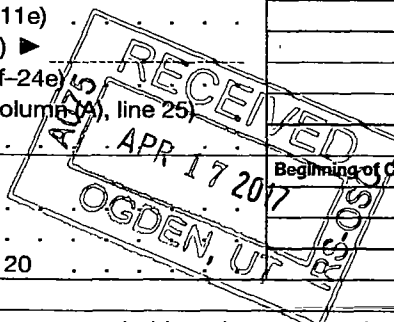

Youth Services, MPower, Wings of Hope, Stillwater Community Health Center, Mission of Hope Shelter for the Homeless, and Stillwater Habitat for Humanity.
