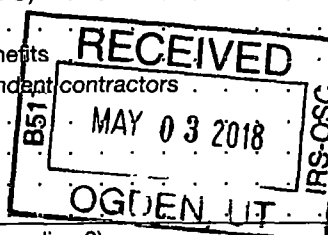

**Part III Purpose**

The purpose of African Radio Ministries Inc. (ARM) is to fund the work of the Lutheran church overseas that shares the Gospel of Jesus Christ and plants churches by using Radio Worship programs. All the US expenses are paid by ARM officers. And all work done for the organization in the US is done by unpaid volunteers.

28 Ethiopian pastors produce Christian worship programs at the studio/office in Addis Ababa. Weekly worship programs are produced in Ethiopia's two most widely spoken languages, Amharic and Oromo. As funds permit programs for smaller languages are also included. The radio pastors visit villages that invite them to establish churches.
