POLICY DEVELOPMENT The organization has a very involved Board or Directors who engage volunteers from its membership. A priority of the organization is the development & implementation of policies relevant to its members and the ag community. During the year, members were asked to submit ideas relevant to them for consideration of future policies. A committee then reviewed options and asked the membership for input through a survey. All members were invited to attend the local policy adoption meeting. The Company's voting delegate presented these results at the State Summer Policy Adoption Conference. Adopted resolutions which were of national importance were then taken to the American Farm Bureau Annual Meeting. The Company then lobbies for adopted policies to be implemented by local, state & national officials. Members also met with the county engineer, various county supervisors, and state & national representatives during the year to discuss & lobby for issues important to agriculture.

PUBLIC RELATIONS Farm safety was promoted and a grain bin rescue campaign was held with local fire departments and Company members. Company leaders attended EMS meetings and communicated with the County EMS Director. Funds were raised and donated to county fire association to purchase grain bin rescue equipment at \$1,785. The Company hosted an Annual Meeting for all members to display and promote member benefits and activities sponsored by the Farm Bureau organization. Company leaders were introduced and recognized to the 86 attendees who also received literature, signs and promotional items. Total annual meeting cost was \$2,522. The Company sponsored a local cookout contest at the County Fair, promoting quality Iowa meat. Several hundred fair attendees stopped by during the contest that involved 10 contestants and 3 judges. \$400 in prizes were awarded to during the event. An annual Country Fest Concert was promoted & sponsored by the Company. This included print, billboard, radio and social media advertising of the event that reached several hundreds of people, \$2500.

EDUCATION/ AG IN THE CLASSROOM The Company communicated with teachers, educators and schools, including FFA advisors, promoting resources and grant opportunities available to incorporate agriculture into the classrooms. The Company also communicated with high school counselors at 5 school districts, providing them with information on local & state scholarships available to students. The Company participated with a 3rd grade Ag Education Day. 300 3rd grade students from local schools gathered at the Fairgrounds for a day of education tours and booths. The Company participated in a Farm Safety Day Camp for 4th-6th grade area students where they were educated about hazards around the farm & to promote safety. The Company has long been a proponent of providing assistance to members graduating seniors through their scholarship program. During the year, 3 - \$1,000 scholarships were awarded. The Company sponsored young farmers to attend the IFBF Young Farmer conference and a District Young Farmer educational workshop. An Ag in the Classroom Workshop was sponsored.
