PUBLIC POLICY: The Company's annual meeting was held in April & county supervisors attended. Attendees were encouraged to fill out opininnaires to help form current year resolutions. In July the Company held a resolution meeting to approve current year resolutions which were then forwarded to the state office to be included with all of the Iowa Counties resolutions. A board member attended the Washington DC legislative trip to lobby for agriculture. The board president attended the Presidents Conference. A board meber attended a regional group visit to Senator Grassley's office where the group raised several questions on concerns facing farmers today. In December, the board of directors finished up the year with an appreciation meeting/dinner inviting local legislators and county supervisor whom the Company had worked with throughout the year on issues & concerns effecting agriculture and farmer members.

EDUCATION/AG IN THE CLASSROOM The Company employs and sponsors an Ag In The Classroom coordinator who visited 162 classrooms and reached 5,889 students at local area schools to discuss the importance of agriculture. A scholarship committee was formed that developed guidelines, accepted & reviewed applications and awarded 9 student scholarships in the amount of \$8,950. In May the Company co-sponsored a 4th Grade Safety Day Camp for Bremer County students. Approximately 320 students attended this event. T-shirts and volunteer lunches wer provided by the Company plus several board members volunteered to serve on the committee and help with the days events. The Company provided to pay member's kids 4-H dues and dues for 70 4-H's were paid totaling \$975.

PUBLIC RELATIONS The Compnay participated in and sponsored a number of events for the benefit of members and non members alike. Th Company sponsored Ag calendars for Farms at \$615. In March the Company co-sponsored with local banks a Farm Bill/Crop Insurance meeting. Several board members attended and \$500 was donated to help pay for meals. The Company hosted a Stroke Detection Plus health screening 4 times during the year. A Health Day with a local hospital was also sponsored which provided members and the general public a low cost 23 profile blood draw. The Company donated and Board members volunteered at the 4-H Omelet Breakfast in March. Napkins, cups and \$750 was donated to this event. The Company sponsored a Farm Bureau Day at the County Fair. Activities for kids at the fair included ice cream in a bag. The Company invited area teachers to participate in a milking challenge to win money for their classrooms to teach agriculture topics. An evening activity was a free watermelon feed where 27 watermelons were provided to fairgoers.
