The Company's board and members then support local and state policy by contacting the representatives and lawmakers. The Company host legislative forum meetings every month to stay in touch with lawmakers. The Company board members attend meetings held at the state capital to support Farm Bureau policy. The Company meets with National representatives to discuss national issues at a regional board meeting.
