Our ARCHITECTURE IN COMMUNITY program uses lectures and tours to educate the public about notable local architecture. Subjects included the Des Moines Public Library, the Catholic Diocese, and the Des Moines Art Center. Our popular Eat Drink Architecture event was once again sold out. Our Walking Tours educate the public about Des Moines architectural legacy--including little-known stories about the architects and significance of the buildings that shape the downtown skyline. Our tour of Des Moines Western Gateway was attended by 60 young professionals. We hosted a day trip to Mason City, site of Iowa's most significant collection of Prairie School architecture. This included a tour and lunch at the Historic Park Inn, the last remaining hotel designed by Frank Lloyd Wright, and tours of the Melson, Blythe and Stockman houses. Together with the Des Moines Art Center, we developed a public exhibit of artwork focused on architecture. We conducted adult education classes with the Des Moines Public Schools, including Tall Buildings, Architectural Styles, and Architectural Photography.

ARCHITECTURE IN SCHOOLS seeks to instill awareness and appreciation of architecture in Iowa's public school students. More than 400 students across Iowa participated in our drawing and photography contests. The 2016 Architecture by Children drawing contest involved students at the K - 6th grade levels, and the Snapshot Iowa photography contest involved students in grades 7 - 12. At a hands-on STEM workshop, Girl Scouts from Central Iowa designed and built model dream houses and landscaped lawns. The dynamic Dream, Design, Build curriculum was led by local female design professionals including architects, landscape architects and engineers. They assisted the Scouts with questions, building techniques, and mastering hot glue guns. Volunteer architects led our Architective tours of downtown Des Moines for central Iowa elementary school children. Other events included tours of the World Food Prize building and Hubbell Elementary school.

The COMMUNITY DESIGN PROGRAM, in its 16th year, brings our resources to the service of communities looking for solutions to local design problems. Our volunteer professionals worked with the cities of Carlisle and Webster City. Teams of design professionals assisted community members, city officials and other stakeholders with visualizing improvements to the business districts, including wayfinding, storefront facades and streetscapes. We held design charrettes to create conceptual plans to guide the communities forward in making improvements. In 2016, team members promoted the program to new participants at the Iowa Economic Development Conference, Preserve Iowa, in Davenport, and the USDAs Rural Development Conference, held in Jefferson, Iowa.
