St. Mark has been serving children and families in the Dubuque area for more than 25 years. When St. Mark Lutheran Church closed its doors in 1988, former parish members and dedicated community members formed a coalition to meet the needs of downtown Dubuque community members - particularly children. St. Mark has grown from serving 13 Prescott Elementary students, to now serving more than 400 Kdgn-5th graders in homework help, focused literacy/reading, creative play, and STEAMM (science, technology, engineering, art, math, music) educational enrichment activities. We also provide a variety of character building and wellness activities to address prevalent youth issues related to health/nutrition, substance use prevention, social-emotional learning, and community engagement/connection. Continued on Schedule O. We provide before/after school programs at four Title I Dubuque elementary schools, and summer programming to the larger Dubuque and Western Dubuque communities. St. Mark hires certified teachers and para-professionals to provide exceptional instruction, mentoring, and social-emotional support to students who need it most. St. Mark is proud to collaborate with numerous community partners and more than 250 volunteers annually. Before School "Early Risers" Program. This program includes homework help, computer time, literacy activities, games and much more. Students can also participate in the school breakfast program. Our goal with this program is to provide a safe place with caring adults to help students get a great start to the school day. After School "Step Up" Program. Our after school academic program for students in grades K-5 offers students a healthy snack, assists students with homework, helps in building character, promotes healthy exercise options, and provides student driven academic enrichment opportunities to help students become well-rounded. The academic enrichment opportunities may include but are not limited to the following areas: art, culture, science, technology, logic, movement, sports and outdoor activities.
