

 THE FRIENDS LOANED THE IOWA NATURAL HERITAGE FOUNDATION (INHF) \$81,000 IN 2015 AND \$79,000 IN 2016 TO PURCHASE A FORTY-SEVEN (47) ACRE IN-HOLDING. SIMILARLY, THE FRIENDS CONTEMPLATE LOANING THE INHF \$79,000 IN 2018 AND \$79,000 IN 2019 TO COMPLETE THE PURCHASE. AT THAT JUNCTURE, BOTH PARTIES ANTICIPATE THE SALE OF THE PARCEL TO THE FWS BASED ON AN APPRAISAL AT THE TIME OF SALE. THE PROCEEDS OF THE ANTICIPATED SALE TO THE FEDERAL GOVERNMENT, LESS THE COST OF PROPERTY MANAGEMENT DURING THE INTERIM PERIOD BY THE INHF, WILL BE RETURNED TO THE FRIENDS. THE BALANCE SHEET REFLECTS A SIMILAR AGREEMENT RELATIVE TO AN EARLIER PURCHASE BY THE INHF INVOLVING A LOAN OF \$1,500,000 BY THE FRIENDS. AT 12/31/2016, BOTH LOANS TOTAL \$1,660,000. THE FRIENDS INTEND TO CONTINUE SUPPORTING PURCHASE OF REFUGE IN-HOLDINGS WITH THESE FUNDS. BOTH PARTIES RECOGNIZE THAT THIS ARRANGEMENT IS LESS THAN "ARMS-LENGTH" AND IS SUBJECT TO THE FEDERAL BUDGET PROCESS. THUS THE PARTIES WILL EXPLORE ALL POSSIBLE OPTIONS WITHIN THE FRAMEWORK DESCRIBED TO INSURE THE PROPERTIES, ULTIMATELY, ARE INCORPORATED INTO THE REFUGE.

SALE TO GOVERNMENT AGENCIES. INITIALLY, THE FRIENDS LOANED \$1,500,000 TO THE IOWA NATURAL HERITAGE FOUNDATION (INHF)

TO ASSIT WITH THE PURCHASE OF A 840 ACRE IN-HOLDING. AN ADDITIONAL 47 ACRE TRACT WAS PURCHASED IN 2015 BY THE INHF

FOR \$318,000. THE FRIENDS LOANED \$81,000 IN 2015 AND \$79,000 IN 2016, AND EXPECT TO LOAN \$79,000 IN 2017 AND 2018 TO

COMPLETE THE RECENT ACQUISITION. AS PREVIOUSLY, THE INHF HOLDS TITLE AND IS ACTIVELY RETURNING THE LAND TO A

NATURAL STATE. UPON EXPECTED RESALES TO THE FEDERAL GOVERNMENT, RESULTING FUNDS MINUS INHF ASSOCIATED EXPENSES

WILL RETIRE THESE LOANS. THE FRIENDS PLAN TO CONTINUE FACILITATING FUTURE LAND ACQUISITION IN THIS MANNER.
