Each AUPO Board of Trustees (Board) member, committee chair, and committee member must disclose and manage conflicts of interest that affect this integrity. Where such conflicts or perceived conflicts exist, they must be appropriately and fully disclosed and managed. The Board has determined that a financial relationship should not restrict expert scientific, clinical, or non-clinical contributions to AUPO's activities provided that appropriate disclosure of such relationship is made. Similarly, it should not restrict participation in AUPO leadership or governance, so long as appropriate disclosure is made. AUPO seeks to ensure balance, independence, objectivity, and scientific rigor in all individual or jointly sponsored educational and leadership activities. The AUPO financial disclosure request must be submitted annually. Disclosure information is kept on file and used during the calendar year in which it was collected for all AUPO activities. Updates to the disclosure information file are made whenever there is a change. When nominated or appointed to a leadership position, each AUPO leader specifically reviews his/her statement on file and notifies AUPO of any changes to his/her financial disclosures. These requirements apply to relationships that are in place at the time of or were in place 12 months preceding the nomination or appointment to a leadership position.
