Every year CCF goes to a different camp and spends 1 week doing work projects to fix, upgrade,
and improve the camp. We brought ~200 students and adults from Kirksville, MO to Oklahoma for a fee of \$175/ person (reduced rates
were available to those who could not afford this). While at camp we work, have time to play sports, games, bible
study and worship, and 1 free day to relax at the camp. Some years we have a surplus from this project, other years we run a
deficit due to factors like fuel price, vehicle breakdowns, food costs, etc. Some surplus will be used to fund the CCF
Spring Break Mission Project in March 2017 to Springville Christian Camp in Odenville, AL.

Most of our events are free but we do charge a small amount for our mens/womens retreat and Valentine Day dinner.
Also, we ask students to pay to attend the National Student Conference. Free events include:
Truman Week events for incoming new students, Fall Party, House Feast, random mens and womens events, prayer meetings, etc.
Again, most events are free for students to attend.

Staff Discipleship and Ministry is a budgeted item that allows each staff person funds to lead discipleship groups, facilitate coaching
groups with our leadership team (approximately 50-70 student leaders), do outreach to new students, and maintain relationships
with alumni. This can also include staff development. These expenses can vary staff person to staff person but the vast majority
include food/coffee for meetings, books, and some fuel expenses for the enrichment and growth of students/alumni.
