Part I Line 3 (see schedule O) Brent Benjamin is paid by the supported organization, The Saint Louis Art Museum. His compensation is approved by the Board of Commissioners of the Saint Louis Art Museum. Changes are approved by the Board each year. The other employees are paid by the supported organization, the Saint Louis Art Museum. Salary surveys, studies and independent compensation consultants are periodically used to determine compensation.

Part II Line C Brent Benjamin's other deferred compensation of \$281,073 consists of a retention plan, 403(b) plan and the estimated change in the actuarial value for a defined benefit pension plan. The Board approved a retention plan for the Director of the Museum in December 2015. The agreement was effective in 2016 and extends through 2018. The 2016 credit is \$125,000. Annual amounts specified at the inception of the retention agreement are to be paid to the plan. The retention plan is 100% at risk with payments contingent upon Mr. Benjamin remaining in the Museum's employment through January 1, 2019. An additional \$15,000 was paid into a Supplemental Cash Balance plan for the Director in 2016. The 403(b) contribution was \$53,000. The change in pension value of \$88,073 is a result of an estimate calculated on the difference in the present value of an annuity payout between the end of the year 2015 and the end of the year in 2016. Retirement and other deferred compensation for Carolyn Schmidt of \$102,200 consists of a retention payment and the estimated change in the actuarial value of the defined pension benefit in the amount of \$50,000 and \$52,200, respectively. Annual credits specified at the inception of the retention plan are paid annually. The retention plan is 100% at risk with payment contingent upon Ms. Schmidt remaining in the Museum's employment on the credit dates. Retirement and other deferred compensation for Carl Hamm, Jeanette Fauz, and Mark Macinski consist of the estimated change in the actuarial value of the defined pension plan benefit in the amounts of \$99,492, \$103,034, and \$38,059, respectively.
