Memorial cards are left at the local mortuary for individuals from the general public to give memorials to the Foundation in memory of loved ones. Information on Sunrise Foundation, Inc is included in a section of the Southwest Healthcare Services annual report booklet along with a personal update from the Sunrise Foundation chairperson at the annual meeting. The Foundation conducts an annual year-end giving campaign that includes mailings and newspaper ads to reach the broad general public to raise funds. The Foundation's main endowment fund was originally contributed by two families, however they also have board designated endowment funds which were contributed by a wide range of donors from the general public. During 2015 the organization lost their Foundation Director just as they were gaining visibility in the community. The organization hired a new Director in 2016 to help them be more active in their process of soliciting funds from a broad variety of sources in the general public. A capital campaign began in 2013 and continued into 2015 for a building project at Southwest Healthcare Services. The capital campaign consisted of mass mailings to the general public, public meetings on the building project as well as news articles on the project. Sources of Support Sunrise Foundation, Inc does not receive support from a single family, rather it receives support from members of the general public. The Foundation received a portion of its support from individuals in the community Representative Governing Body Sunrise Foundation, Inc is served by a governing body that represents the interest of the public, it does not represent the interests of the donors of Sunrise Foundation, Inc. These representatives ensure that the Organization meets the needs of the healthcare community. Board members come from the Organization's surrounding communities. Based on the above facts and circumstances, Sunrise Foundation, Inc should continue to be considered as publicly supported under Internal Revenue Code Section 509(a)(1) and 170(b)(1)(A)(vi).
