including conflict of interest. The board president and staff monitor activity on an ongoing basis to determine if there are any

potential conflicts. If a conflict arises, the board member must abstain from the vote. All potential conflicts are to be

disclosed by all board members.

For 990, Part VI, Section B, Line 15: Compensation of the directors, any staff and independent contractors is determined by review

of salaries from North Dakota Job Service and other organizations. The Executive Committee makes a recommendation on the

compensation and the full board approves the final compensation with the annual budget.
