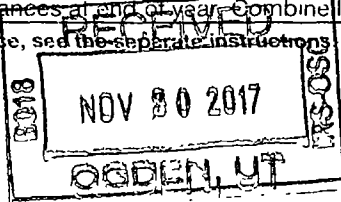

This number also includes \$515 in non-grant expenses for the Santas Without Chimneys program service, \$104 for two organization directors to attend a nonprofit workshop conference held in Madison, WI (no travel expense) and \$72 that is believed to have been stolen from an ASO account by an outside card reader skim (money was spent at a fast food restaurant and multiple gas stations on small purchases).

Part I, Line 20 - This item reflects \$7673 in donated space, a \$300 in-kind donation of U-Haul boxes, \$107 in PA system depreciation and a write-down to zero of inventory previously reported on the 2015 Schedule O, Part I Line 24(a) as worth \$761.

Part II, Line 24(a) - This item consists of a depreciable PA system valued at \$215, copyrights valued at \$105, excess unallocated Santas Without Chimneys gift cards valued at \$1067, specific high value donated items (American Girl dolls) valued at \$2,850 and excess unallocated Santas Without Chimneys in-kind donations valued at \$15,475.

Part II, Line 24(b) - This item consists of a depreciable PA system valued at \$107, copyrights valued at \$105, specific high value donated items reported in Part I, Line 24(a) (American Girl dolls) valued at \$1100 following inventory reduction by distribution to child request in the Santas program service and excess unallocated Santas Without Chimneys in-kind donations valued at \$37,963. In-kind carry over dramatically increased relative 2015 due to higher than expected "adoption" uptake (directed P2P donation) and corresponding high levels of community support for general in-kind donations at the same time, leading to substantial excess donations of new toys
